

THE ENSURE CAN DO GIVEAWAY
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE 18 YEARS AND OLDER AT THE TIME OF ENTRY.

The Ensure Can Do Giveaway (“Giveaway”) is sponsored by Abbott Laboratories, (“Sponsor”), 100 Abbott Park Road, Abbott Park, Illinois 60064, and administered by Prize Logic, LLC (“Administrator”), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. GIVEAWAY PERIOD:** The Giveaway begins on July 10, 2017 at 12:00 PM (noon) Eastern Time (“ET”) and ends on October 31, 2017 at 11:59:59 PM ET (“Giveaway Period”). The Giveaway consists of eight (8) separate entry periods (each, an “Entry Period”), each with two (2) separate random drawings (each, a “Random Drawing”), as set forth in the chart below (all times ET):

Non-winning entries submitted into an Entry Period will carry forward to subsequent Entry Periods. Further, all eligible entries received in all Entry Periods will be entered into a drawing for the Grand Prizes (as further described in Section 5). Administrator’s computer is the official clock of the Giveaway.

- 2. ELIGIBILITY:** This Giveaway is offered only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years and older at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries and affiliates, distributors, and companies involved in the implementation and execution of the Giveaway (“Giveaway Entities”) and each of their respective immediate family members (i.e., spouse, parent, child, sibling and the “steps” of each) and persons living in the same household of each are not eligible to participate in the Giveaway. Void where prohibited or restricted by law. By participating in this Giveaway, an entrant agrees to be bound by these

Official Rules and that the decisions of Sponsor shall be final and binding in all matters pertaining to the Giveaway. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator.

3. HOW TO ENTER THE GIVEAWAY: During the Giveaway Period, an eligible entrant will participate in various activities to obtain Giveaway entries, as set forth below.

An entrant must first register for the Giveaway by visiting CanDoGiveaway.com (“Website”) and entering his/her valid e-mail address. The entrant must then provide the required registration information, which may include, but is not limited to, his/her first and last name (no initials), street address (no PO Boxes), city, state, ZIP Code, daytime telephone number, and confirmation that he/she is at least 18 years of age and has read and agrees to these Official Rules. Upon submission of a valid e-mail address and the complete registration information, an entrant will receive one (1) entry into the active Entry Period’s Random Drawing. Every day thereafter an entrant may return to the Website and enter his/her valid e-mail address to receive one (1) additional entry into the active Entry Period’s Random Drawing. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Giveaway, then that entrant, in Sponsor’s sole discretion, may not be eligible to win a prize.

After completing the registration information, the entrant will then access his/her “Dashboard”. From the Dashboard, the entrant will see his/her available activities and be able to select activities to obtain additional entries. Each calendar day thereafter during the Giveaway Period, an entrant may return to the Website, submit his/her e-mail address provided when registering for the Giveaway to access his/her Dashboard and participate in any available activity.

- A. Opt-In To The Ensure Healthy Matters Program:** An entrant may obtain twenty-five (25) entries into the active Entry Period’s Random Drawing by opting-in to the Ensure Healthy Matters program. An entrant may unsubscribe from receiving program-related e-mails at any time by following the “unsubscribe” link in any such e-mail. An entrant may only opt-in once during the Giveaway Period to receive a total of twenty-five (25) Giveaway entries.
- B. Share on Facebook:** An entrant may follow the instructions on his/her Dashboard and set forth below to share the Giveaway on Facebook. Upon clicking the button to share the Giveaway, a message with a unique link will be posted to the entrant’s Facebook Wall (“Invitation Post”). Receipt Upload/Mail-In Non-Purchase Method:** An entrant may follow the instructions on his/her Dashboard to upload an image of his/her original register receipt showing the purchase of any Ensure product during the Giveaway Period to receive ten (10) entries into the active Entry Period’s Random Drawing. - E. Watch a Video:** An entrant may obtain five (5) Giveaway entries into the active Entry Period's Random Drawing by watching a video posted to the Website ("Video"). See the chart above for the participation limits for this method of entry.
- F. Take a Poll:** Each Entry Period during the Giveaway Period a new poll will be available through the entrant's Dashboard. An entrant will receive three (3) Giveaway entries into the active Entry Period's Random Drawing by completing a poll. See the chart above for the participation limits for this method of entry.
- G. Take a Quiz:** During a participating Entry Period during the Giveaway Period a new quiz will be available on the entrant's Dashboard. An entrant will receive five (5) Giveaway entries into the active Entry Period's Random Drawing by completing a quiz. See the chart above for the participation limits for this method of entry.

If it is discovered or suspected, in Sponsor's sole discretion, that an entrant has registered or attempted to register for the Giveaway using multiple e-mail addresses or identities, or if an entrant enters or attempts to receive more entries than are set forth in these Official Rules, all of that entrant's entries, in Sponsor's sole discretion, may be declared null and void and any prize he/she might have been entitled to will not be awarded to him/her. On or about November 13, 2017, the Administrator will randomly select three (3) potential grand prize winners (each, a “Grand Prize Winner”) from among all eligible entries received during the entire Giveaway Period.
